对于任何恶意使用、恶意抢注"华集"及近似商标、商号的行为;注册有关"华集"字号的或相近的企业名称混淆视听销售假冒"华集"品牌产品;私刻我公司假公章销售假冒"华集"品牌产品;对于任何恶意攻击"华集"产品的,以及恶意仿冒、生产、销售"华集"产品的行为;严重侵犯了我公司的商标权、商号权,我公司将通过国家知识产权局、各级市场监管部门、各级法院予以严厉的打击、绝不姑息,甚至升级到刑事高度,以维护我公司的合法权益和"华集"声誉。

relevant "Huaji" brand names or similar enterprise names to confuse the public and sell counterfeit "Huaji" brand products, privately engraving our company's fake official seal for use in bidding authorization letters, privately engraving our company's fake official seal for use in selling counterfeit and inferior goods delivery lists, privately engraving our company's fake official seal for use in selling counterfeit and inferior goods testing reports, etc. The situation is extremely serious. In fact, the "Huaji" trademark has been held and used by our company and has not been authorized to other companies for production. In addition, these sales of counterfeit "Huaji" products have extremely poor quality, seriously harming customers, damaging the interests of customers and owners, infringing on the legitimate rights and interests of our company, and seriously disrupting market order.

For any malicious use, malicious registration of "Huaji" and similar trademarks and trade names; Registering companies with the "Huaji" brand name or similar names to confuse the public and sell counterfeit "Huaji" brand products; Selling counterfeit "Huaji" brand products by privately engraving our company's fake official seal; For any malicious attack on "Huaji" products, as well as the act of maliciously counterfeiting, producing, and selling "Huaji" products; The company has seriously infringed our trademark rights and trade name rights.
